

Prices

The rate in force on the date of order request will be applied. Prices do not include the ECORAE rate or specific taxes according to the scope of application.

The fare prices are considered to be Factory (Ex Works).

Deadlines

Delivery times will be confirmed at the time of placing the order. Always being a guideline. The delays that may exist will not imply the cancellation of the order or sanctions on the part of the client.

Transport

Shipping will be charged to the customer. The rate includes factory prices (Ex Works).

Cancellations

They must be processed in writing prior to being put into production. Orders that have gone into production cannot be canceled.

For orders outside the rate, cancellations will not be accepted.

Returns

They must be authorized by the company, upon request for RMA and must carry an authorization number. The maximum term for returns is 30 days from the date of issue.

The return shipping will be paid by the customer.

Fertilizers

They will be discounted on the first invoice that is originated, provided that the material has not suffered alterations or damages. A depreciation of 10% will be applied on the amount of the material.

Samples

They must be requested in writing and will be billed. In case of return, the buyer will assume the postage and will be paid in full, unless they have suffered damages.

Warranty

All products have a 5-year warranty period against manufacturing defects *. The liability of the company is limited to the price of defective products and / or against manufacturing defects, and no other liability for warranty or any other concept will be required. The products will lose their warranty if they are manipulated by unauthorized technicians.

Quality

All of our products are CE certified. In addition, they have passed a rigorous quality control to ensure their correct operation. We are constantly working to improve quality. For this reason, we reserve the right to modify, cancel and expand our products to satisfy our quality requirements.

Jurisdiction
